Minutes of Part 2 of the Council meeting

Present

The Council Members discussed the summary resignation of Mrs Bowland Clerk to the Council dated the 4th September and subsequent letters from her lawyer of the 10th September (setting out her claim for Constructive dismissal) and the 11th September (a without prejudice offer to settle the claim for a settlement sum of £2000 plus costs in return for the return of Council property.

Following the discussion it was moved by Clir Holder that:

- The Claim by Mrs Bowland was not considered valid.
- That attempts are continued to be made to meet with Mrs Bowland to resolve her issues with the Council.
- That Clirs Holder and House collaborate on a rebuttal letter to be sent to Mrs Bowland's lawyer.
- That Cllr Sant immediately take on the role of Clerk to the Council (unpaid)
 until such time as the matter is resolved or an interim clerk found, subject to
 his agreement upon return from holiday.
- That Kate Pepper of Sandbach Town Council (a previous deputy of Mrs Bowland) be approached with a view to appointing her as Interim Clerk to the Council on a temporary contract if the matter is not resolved.
- That given that Mrs Bowland is holding the Council's property hostage
 including access to the website and banking, Councillors will continue to seek
 advice from CHALC, contact Cheshire East electoral services for help and
 advice, Cheshire West to facilitate access to the website and Natwest Bank to
 secure a change of signatories.
- That this is a sensitive matter and that it is in the interest of both parties that matters are dealt with sensitively and confidentially.
